### Queensland Social Housing Register

2023 Data Release Evidence Brief



This summary report reviews the details of applications for social housing recorded in Queensland's Social Housing Register as at 30 June 2023. Information is included on 25,364 housing register applications, including the type of assistance required and the level of assessed housing need. Over the latest 12-month period, approximately 7,000 households were removed from the social housing register, about half of which because they could not be contacted. New technology information systems were implemented by the Queensland Government in 2019-20, which resulted in some changes to data structures and coding. As a result, comparisons across years may be impacted.

### Summary

- There were 25,364 applications on the Queensland social housing register
- The number of people on social housing register applications was 41,484
- Of the 25,364 applications on the register, 6,570 were new applications (25.9 per cent)
- Approximately 7,000 households were removed from the register over the 12month period, about half of which because they could not be contacted.<sup>1</sup>
- 12,765 applications on the social housing register were flagged as people experiencing or at risk of homelessness (50.3 per cent)
- 25,220 applications were assessed as high or very high housing need (99.4 per cent)
- 17,659 applications were for single person households (69.6 per cent)
- 5,384 applications were single parent family households (21.2 per cent)
- The average number of months an application was on the register increased from 15.5 months in 2017 to 27.9 months in 2023


- 11,760 applications were for households including persons with a disability (46.4 per cent)
- 8,951 applications were for Aboriginal and Torres Strait Islander households (35.3 per cent)
- The top three Housing Service Centre locations where an application was lodged were Cairns (10.3 per cent), the Gold Coast (9.2 per cent), and Townsville (8.3 per cent)
- Brisbane Local Government Authority had the largest number of applications (4,782), followed by Moreton Bay Regional Council (2,356) and Townsville City Council (2,042)
- State Electorates of Mundingburra, Cairns and Bonney were listed with the highest number of applications based on applicant household's first locational preference
- Aitkenvale, Beenleigh and Edge Hill letting areas (suburbs) were listed as the top three letting areas based on applicant household's first locational preference





### **Total applications**


The number of applications on the social housing register increased from 15,657 in 2017 to 25,364 in 2023, representing an increase of 9,707 applications (62.0 per cent). The number of people on social housing register applications increased from 29,636 in 2017 to 41,484 in 2023, representing an increase of 11,848 people (40.0 per cent). Of the 25,364 applications on the register, 6,570 were new applications (25.9 per cent) over the last financial year. Approximately 7,000 households were removed from the register over the 12-month period, about half of households were removed because they could not be contacted.<sup>1</sup>



#### Number of months on register

Applicants are waiting longer on the register. For June 2023, applicant households were on the social housing register for an average of 27.9 months, an increase from 15.5 months in 2017. At June 2023, of the applicant households registered:


- 29.0 per cent were registered for one year or under
- 26.9 per cent were registered for more than one year but less than two years
- 16.7 per cent were registered for two years or more but less than three years
- 27.4 per cent were registered for three years or more.





#### Level of assessed housing need

For June 2023, almost all households on the register had their level of housing need assessed as 'very high' or 'high' (99.4 per cent). Only 12 households were assessed as 'lower'. Since 2019, the department has classified all new applicants on the register as very high need<sup>2</sup>.




#### Number of people listed on the application

The majority (69.6 per cent) of households listed one person on the application. A further 3,455 (13.6 per cent) listed two people on the application, 7.6 per cent listed three people on the application, 4.8 per cent listed four people and 4.4 per cent listed five or more people on their application.

### Family type of applicant household

17,659 applications were from single person family households (69.6 per cent), followed by 5,384 applications (21.2 per cent) for single parent family households.





#### **Bedrooms required**


Most commonly, the number of bedrooms an applicant household was entitled to was one bedroom (54.6 per cent), followed by 20.9 per cent for two bedrooms, and 18.1 per cent for three bedrooms.

### Households including persons with an identified disability


Almost half of all applications include a person with an identified disability (46.4 per cent). The number of applications including persons with an identified disability increased from 6,848 in 2017 to 11,760 in 2023.

### Homelessness

As at 30 June 2023, 12,765 applications on the register (50.3 per cent) were households flagged as homeless or at risk of homelessness at time of application, an increase from 8,460 in 2017.








The number of applicant households that include persons that identify as Aboriginal and/or Torres Strait Islander increased from 3,545 (22.6 per cent of applications) in 2017 to 8,951 (35.3 per cent of applications) in 2023.


As at June 2023, Wujal Wujal had the highest average time for applications on the register (68.0 months), followed by Hope Vale (67.1 months), Hammond Island (58.0 months), Mapoon (50.9 months), Mornington Island (50.3 months) and Kowanyama (47.7 months).

### Local Government Authority

Local Government Authority data are determined based on the applicant household's first locational preference. As at June 2023, Brisbane LGA had the largest number of applications (4,782), followed by Moreton Bay Regional Council (2,356), Townsville City Council (2,042) and Logan City Council (2,039).

As at June 2023, Hope Vale Aboriginal Shire Council had the highest average time for applications on the register (65.6 months), followed by Lockhart River Aboriginal Shire Council (56.3 months), Mornington Shire Council (51.9 months), Palm Island Aboriginal Shire Council (51.7 months) and Mapoon Aboriginal Shire Council (51.4 months).





### Letting Area

Letting Area (suburb) data are determined based on the applicant's first locational preference. Aitkenvale, Beenleigh and Edge Hill areas were listed as the top three letting areas, with a first locational preference of 7.1 per cent, 4.2 per cent and 4.1 per cent respectively. 1,210 applications were listed with a letting area preference as "N.A.".
